## TERMS OF DELIVERY AND IMAGE PRICES

1. Orders for reproductions of art works and objects from Museum Het Valkhof's collection must be submitted in writing (using a signed application form) to Tosca Philipsen, registrar, Postbus 1474, 6501 BL Nijmegen, The Netherlands
2. The museum charges the following fees for the use of images:
  - reproduction fee per image € 10.00 for a jpeg file and € 25.00 for a tiff file
  - copyright fee for once-only use € 50.00 per image
  - administration fee € 7.00 per order
  - prices shown are excluding 6 % VAT
3. The delivery period for regular orders is three weeks, counted from the date of receipt of the application form.
4. The delivery period for rush orders is seven working days at the most, also counted from the date of receipt of the application form. A surcharge of 100% of the total cost will be charged for rush orders.
5. On publication or other public use of the image(s), the source must be mentioned as follows: Museum Het Valkhof, Nijmegen.
6. Permission is granted for *once-only* use of the delivered image, as described in the order. A new copyright license is required for reprints or when the image is used for purposes other than those described in the order.
7. A reference copy of the publication in which the requested image(s) appear must be sent a.s.a.p. to the librarian of Museum Het Valkhof, Postbus 1474, 6501 BL Nijmegen, The Netherlands.
8. In the following cases there will be no copyright charges:
  - for private use of ordered images
  - for the use of ordered images in the context of research, study or dissertation (provided it is published on one's own) and exhibition catalogues (provided they are published by the relevant museum)
  - for monographs that are important for research on the collection of Museum Het Valkhof Nijmegen. In this last case a fee may be charged for services provided
9. If the recording of an object is labour-intensive, Museum Het Valkhof reserves the right to charge a higher reproduction fee. In this case, the customer will be consulted in advance.
10. On placing an order for a photo, the customer agrees to the above-mentioned terms of delivery and the fees charged by Museum Het Valkhof.
11. The customer is required to pay within 30 days of the invoice date.
12. These conditions and fees are valid as of 1 January 2010.
